FEE SCHEDULE

COMMUNITY SERVICE

**\$1.00 per/hour or a Minimum Fee: \$50.00**

TRANSFERS FROM OTHER COUNTIES MUST PAY COMMUNITY SERVICE FEES BEFORE YOUR HOURS WILL BE SCHEDULED. FAILURE TO PAY WILL RESULT IN A REVIEW HEARING TO BE SCHEDULED IN THE MARTIN CIRCUIT COURT OR YOUR PROBATION MAY BE EXTENDED TO ALLOW YOU MORE TIME. THE PARTICIPANT MAY DECREASE FEE DEBT FOR EVERY DOLLAR OWED BY WORKING ONE HOUR. (EX: \$64.00 = 64 ADDITIONAL HOURS).

HOME DETENTION ELECTRONIC MONITORING

**Pre-Trial Interview Fee: \$50.00** (Fee must be paid before interview and will be applied if accepted into a program)

G.P.S./Remote Breath/SCRAM DIGITAL CELL MONITORING

**Minimum:**

**\$15.00 per day + \$50.00 adm. fee + \$25.00 drug screen fee = \$285 Due Day of Hook-up**

**Maximum:**

Personal Wage per hour per day (2 wks in advance) + \$50.00 adm. fee + \$25.00 drug screen fee = Undetermined

DAY REPORTING (Supervision dictated by Need)

**\$5.00 per day + \$25.00 adm. fee + \$25.00 drug screen fee = \$120 Due Day of Set-up**

Level 1: \$5.00 p/day 1 contact every 2 weeks

Level 2: \$5.00 p/day 1 contact & 1 face-to-face every month; random drug screening (according to IRAS and/or pursuant to Court Order)

Level 3: \$5.00 p/day 2 contacts & 2 face-to-face meetings every month; random drug screening (according to IRAS and/or pursuant to Court Order)

Level 4: \$10.00 p/day GPS 2 face-to-face monthly; random drug screen (according to IRAS and/or pursuant to Court Order)

Level 5: \$10.00 p/day GPS Home Detention; restricted schedule; random drug screen (according to IRAS and/or pursuant to Court Order);

minimum 2 face-to-face monthly

CTP (Effective 7/1/14 DOC Rate Change)

**\$10.00 per day (2 weeks in advance) + \$25.00 Drug Screen Fee = \$165.00**

DRUG SCREENS

**Positive Drug Screens (without a verifiable script) - \$25.00**

**Positive Drug Screen (with a verifiable script) - \$20.00**

**Any Drug Screen used as part of a sanction - \$20.00**

**Saliva Test Screens used for clients unable to provide a specimen - \$20.00**

**Saliva Test used due to personal choice - \$20.00**

ADDITIONAL FEES

**Non-Component Programming Fee: \$50.00 per Program**

**TRANSFER FEE: \$125.00** Fee must be paid before paperwork is faxed to Receiving County.

**MOVING FEE: \$25.00** Must be approved 1 week in advance.

**SL2 REPLACEMENT FEE: Unit \$800.00**

**GPS REPLACEMENT FEES: Strap (1) = \$60.00; Transmitter = \$1740.00; Beacon/Receiver = \$250.00 Wall Charger \$60.00**
